## VILLAGE OF PEWAUKEE

**A RESOLUTION AMENDING AND ESTABLISHING CERTAIN FEES RELATED TO  
FOREST HILL CEMETERY, LOCATED AT 300 SCHOOL STREET, IN THE  
VILLAGE OF PEWAUKEE, WAUKESHA COUNTY, WISCONSIN**

WHEREAS, the Village Board of the Village of Pewaukee presides over the management of all Village-owned cemeteries;

WHEREAS, the Village Board has reviewed the charges and fees applicable to the use and maintenance of the Forest Hills Cemetery and based on the totality of the circumstances has determined that certain fees and charges shall be amended and that those amendments are reasonable and reflect the Village's actual cost of providing the service indicated and the market value of grave lots;

NOW, THEREFORE, BE IT RESOLVED, the following fees and charges are hereby approved and are effective January 1, 2022:


BE IT FURTHER RESOLVED, residency for the purpose of interment/disinterment fees will be determined at the time of the purchase of the grave lot. In the event that the address for the plot owner is not provided on the Village of Pewaukee records, it will be assumed that the owner was a resident of the Village and will be charged the resident interment/disinterment fee.

BE IT FURTHER RESOLVED, the above fees and charges shall be in effect until changed by further resolution and any earlier resolution or motion inconsistent with this resolution is hereby to the extent of its inconsistency with this resolution repealed.
