Meeting Minutes

March 6, 2024

I. Call to Order/Roll Call

President Spakowicz called the meeting of the Village of Pewaukee Police Commission to order at 5:10 p.m. on March 6, 2023. Secretary Rohde conducted a roll call. The following persons were present: Commissioners Gehrking, Bublitz and President Spakowicz. Commissioner Borckmann was running late for the meeting. Chief Timothy Heier and Sergeants Lucas Twelmeyer and Deputy Chief Brian Foth were also present.

II. Citizen Comments

There were no citizen comments. Chief Heier had no concerns from the citizens.

III. Approval of Minutes of Previous Meeting

The minutes of the November 14, 2023, meeting was presented for review. Commissioner Gehrking made a motion to accept the minutes with the added correction of the spelling of Commissioner Borckmann's last name. Commissioner Bublitz seconded the motion. The motion passed unanimously.

IV. Review of 2023 Annual Report on the Current Status of the Police Department and Department Programs

Sergeant Luke Twelmeyer presented the Commission with a report (Handout) on the Lake Patrol. No concerns regarding the performance of the Lake Patrol were raised.

The 2023 Annual Report for the Village of Pewaukee Police Department was presented by Chief Timothy Heier. No concerns regarding the performance of the Police Department were raised. Commissioner Borckmann arrived at 5:33pm during the annual report review.

V. Review of the Merit Awards Ceremonies Order of Events

Chief Timothy Heier reviewed the order of events with the Merit Awards to the Police Commission.

VI. Closed Session

Commissioner Gehrking made a motion that the Police Commission move into closed session pursuant to Wisconsin Statues Section 19.85(1) (c) to consider employment, promotion, compensation, or performance evaluation data of any public employee over which the governmental body had jurisdiction or exercises responsibility – specifically regarding Lake Patrol Officer candidates. The motion was seconded by Commissioner Bublitz. A roll call vote was taken by Secretary Rohde. The motion passed unanimously. The commission moved into closed session at 6:02 p.m.

Commissioner Gehrking made a motion to reconvene into open session. Commissioner Borckmann seconded the motion. Secretary Rohde took a roll call vote and the motion passed unanimously. The Commission reconvened into open session at 6:07 p.m.

President Spakowicz made a motion to forward the name of Timothy Sean Paterson to Chief Heier to be hired as Lake Patrol Officer after all requirements and the background check is completed. Commissioner Gehrking seconded the motion. The motion passed unanimously.

President Spakowicz made a motion to adjourn, which was seconded by Commissioner Gehrking. The motion was passed unanimously. President Spakowicz adjourned the meeting at 6:09 p.m.
